Concerning: PTV 869 / TRA 69

The last years there has been put a lot of effort to change and optimize the certification of Road Restraint systems.

Recently the Board of directors from COPRO approved the new regulations and technical prescriptions for road restraint systems.

The regulations TRA 69C version 2.0 has been renamed and transformed into TRA 69-1 version 3.0. The regulations TRA 69B version 3.0 has been restructured and divided into 4 different parts. There are no major changes regarding to the certification requirements.

The restructuring resulted into 5 new editions:

- TRA 69-1: Parts for non-tested safety barriers
- TRA 69-2: Safety barriers from steel
- TRA 69-3: Crash cushions and terminals
- TRA 69-4: Safety barriers from in situ concrete
- TRA 69-5: Safety barriers from wood-metal

These changes have been widely discussed during the meetings of the Sectoral Commission of road restraint systems from which you were briefed by meeting reports.

Your products which were certified under TRA 69C and/or TRA 69B will automatically be transferred to the relevant TRA-x. You will also receive a new updated certificate for each relevant TRA-x.

The new regulations and PTV 869 will be applied from the 1st of January 2020. In the meanwhile there will be a transition period to settle the administrative changes.

Concerning: CRC 01 COPRO/BENOR

As you know, the TRA's (Application Regulations) supplement the General Certification Regulations CRC 01 COPRO/BENOR.

These General Certification Regulations CRC 01 COPRO/BENOR date back some years and were due for a thorough revision.

One of the updates concerns digital transmission of the inspection reports. We also had to implement a number of changes in the context of our accreditation. Furthermore, the terminology of a number of specific terms has been adjusted.

Enclosed we are also sending you the new version of CRC 01 COPRO/BENOR. This document applies immediately.

A summary of the most important changes is set out below.
