1 INTRODUCTION

1.1 TERMINOLOGY

The terminology used in these tariff regulations is analogous to the terminology used in the Application Regulation TRA 84 BENOR.

1.2 AVAILABILITY OF THIS TARIFF REGULATION

An up-to-date version of this tariff regulation is available on request from the certification body.

1.3 STATUS OF THIS TARIFF REGULATION

This is version 1.0 of this tariff regulation.

This tariff regulation was approved by COPRO on December 23rd 2022.

1.4 HIERARCHY OF RULES AND TARIFFS

If certain rules or tariffs of these tariff regulations conflict with rules or tariffs of TAR BENOR or TRA 84 BENOR, then the rules and tariffs of this tariff regulation are decisive.

2 TARIFFS

2.1 BASIC TARIFFS

The tariffs below are the basic tariffs for 2023.

2.2 CERTIFICATION FEE

The amount of the certification fee depends on the number of product groups for which the manufacturer is certified:

- in case of certification according to 1 product group: € 3556,65 per year;
- in case of certification according to 2 product groups: € 4717,60 per year;
- in case of certification according to 3 product groups: € 5428,93 per year;
- in case of certification according to 4 product groups: € 6143,69 per year.

2.3 INSPECTION FEE

Fixed fee:

For standard inspections, the fixed fee amounts to € 1214,65 euro per inspection.

For additional and all other type of inspections, the fixed fee amounts to € 377,00 euro per inspection.

Performance fee:

For standard inspections, the prestation fee is not applicable.

For additional and all other type of inspections, the prestation fee amounts to € 131,59 per hour.

Moving costs:

The amount for travel outside Belgium is € 131,59 per hour of travel, counting from Brussels. This does not include the transport costs.

The transport costs and accommodation costs are charged as described in TAR BENOR.

2.4 OTHER TARIFFS

All other tariffs within the framework of product certification of base road materials are according to TAR BENOR.
